The symposium is hosted by the Commercial Real Estate Data Alliance (CREDA) and the Institute for Private Capital (IPC) at the University of North Carolina at Chapel Hill's Kenan-Flagler Business School.

We invite submission of theoretical and empirical papers in the field of real estate finance and investing at all stages of completion (including work-in-progress and extended abstracts). We especially encourage submissions of high quality academic and applied research focused on commercial real estate. The organizers will also accept proposals for panel discussions (including suggested participants). The symposium will also include a special session on preliminary work with authors presenting new ideas in a "3-slide session." Submissions for this session should include a short overview of the topic to be presented.

Papers should be submitted any time before the **deadline of May 15, 2020**. Please include your full name, title, name and address of affiliated institution/university/company, and a confirmed conference presenter.
